Sub: Issue/grant of "public performance" licences by Phonographic Performance Ltd

1. We are a Music company, owning and controlling copyright to many songs and music albums (sound recordings), in film and non-film genres, both new releases and catalogue, in Hindi, Punjabi, Tamil, and various other Indian languages.
2. We are a long-standing member of M/s. **Phonographic Performance Ltd**, having registered office and head office at 7th floor, Crescent Towers, Off New Link Road, Andheri W, Mumbai ("PPL"). PPL is a voluntary association / body of more than 250 music labels across India and we are one such member.
3. As a member of PPL, vide written transfer / assignment agreement, we have assigned exclusively to PPL the right in respect of "Public Performance" for our songs, music albums. This also includes our sound recordings communicated via music videos and film song videos (audio-visual mediums).
4. "Public Performance" herein refers to playing of our music in public places and / or by commercial establishment -- just to cite a few examples: hotel, lodge, restaurant, disco, pub, bowling alley, shop, store/shop, mall, spa, clinic/hospital, bank, office, business park, amusement park, aircraft/airlines, airport, bus, ship/boat, train/metro train, event, show/function, parties, sports stadium, open ground, DJs, township or any other premises / space where Public Performance of music is been done. This covers playing of sound recording through cassettes, CD, loud-speaker system, piped music, radio set, television set, local network, cable, wi-fi, computer, mobile, etc., at premises, establishments and grounds. Thus "public performance" includes and covers both (i) "background music" and "featured music"; and also (ii) music in events / shows / functions held in premises, hotels, open grounds etc.
5. Our said transfer/assignment agreement in favour of PPL is executed U/s 18 and 19 of the Indian Copyright Act, 1957, including the right to PPL to grant and issue licences to users and to collect fee against the same. Accordingly, PPL is empowered and entitled to grant and issue, in it's name, letterhead and invoice, "Public Performance" Licences to establishments, organisations, premises, event organizers/managers, DJs etc. for our songs and music albums (including through audio-visuals of music videos) produced / published under our various labels. These Licences are issued by PPL U/s 30 and other relevant provisions of the Indian Copyright Act.
6. Copyright of our music label will be infringed when any person without the Public Performance Licence granted by PPL, communicates any of our Copyrighted Music / Sound Recording (published under different labels) in any such public place or premises or establishment or knowingly permits for profit his place / premises / facilities to be used for the communication of our copyrighted music to the public. Such infringement shall be deemed to be an offence U/s 63 of the Copyright Act 1957 and PPL is empowered to take

necessary legal action (both civil & criminal) as per the Copyright Act 1957 for such offence.

7. Further, the right to follow-up and enforce the Copyright for "Public Performance" against violations, infringements and non-payment of Licence fees --including by means of litigation (both civil and criminal) and police action-- is with PPL. Accordingly, PPL's representative / executive is duly and solely entitled to file police complaints, FIRs, magistrate complaints, criminal complaints, send notices, etc. in respect of infringements and attempted infringements of any of our entire Sound Recordings repertoire, produced under our different labels.
8. Failure to take PPL Licence for usage of copyrighted music / sound recording in any commercial establishment / public place in advance for the event / show, in respect of Sound Recordings published by us, is a violation and infringement of Copyright as per Sec 51 of the Copyright Act 1957 and is a civil and criminal offence.
9. The transfer of copyrights given by us to PPL are valid throughout India for the period upto 31.3.2018 and is open to renewal/extension.
10. Our name as member of PPL is shown in the web-site of PPL.
11. This letter of confirmation is signed by the authorised signatory.
