**Sub: Issue/Grant of "Public Performance" License by Phonographic Performance Ltd. of our copyrighted songs (sound recordings)**

1. Super Cassettes Industries Private Limited is an established and long-standing music label, also popularly known as "T-series". Our vast catalogue includes songs of various albums, both, in the film and non-film genre, in Hindi, Bengali, Marathi, Tamil, Telugu, Punjabi and other languages. We own and/or control the necessary copyright all the songs forming part of our catalogue which includes rights in more than 1,50,000 sound recordings in various languages across India which we have produced and/or acquired under necessary agreements with producers thereof.
2. In the capacity of being an owner and/or rights holder in these sound recordings, we have the exclusive right to exploit, monetize and enforce the same, either directly or indirectly through a licensee.
3. We hereby confirm that we have granted an exclusive authorization in favour of PPL to grant and issue licenses, *inter-alia*, in relation to use of our sound recordings (to be amended from time to time), throughout India, with respect to playing of our songs at public places and commercial establishments including but not limited to hotels, lounges, restaurants, malls, events, shows, shops, fashion shows, functions, DJs and other premises, venues and commercial establishments etc. (hereinafter referred to as "Public Performance")
4. We confirm that the ownership of copyright in these sound recordings will continue to vest with us, however, the right to exploit, monetize and enforce the Public Performance of the same has been exclusively granted by us in favour of PPL and any use of these sound recordings by way of Public Performance without taking an appropriate written license from PPL in this regard shall constitute copyright infringement which shall be punishable, both with civil as well as criminal punishments under the provisions of the Copyright Act. We have specifically authorized PPL to initiate appropriate legal proceedings in this regard to enforce any violations and unauthorized usages of our songs by way of Public Performances by any one in India.
5. All other rights shall remain reserved with us.
